# UNITED NATIONS COMMITTEE ON THE ELIMINATION OF DISCRIMINATION AGAINST WOMEN TO MEET IN GENEVA FROM 8 TO 26 JULY

Committee to Consider Reports Presented by Cuba, Afghanistan, Democratic Republic of the Congo, Dominican Republic, Cape Verde, United Kingdom, Serbia and Bosnia and Herzegovina

4 July 2013

The Committee on the Elimination of Discrimination against Women will hold its fiftyfifth session at the Palais des Nations in Geneva from 8 to 26 July, during which it will review reports presented by Cuba, Afghanistan, Democratic Republic of the Congo, Dominican Republic, Cape Verde, United Kingdom, Serbia and Bosnia and Herzegovina on how they implement the provisions of the Convention on the Elimination of All Forms of Discrimination against Women.

States parties to the Convention commit themselves to ending all political, economic, social, cultural, civil or other forms of discrimination against women. The Committee, a 23-person expert body, monitors compliance with the treaty. It assesses to what extent each State is meeting its obligations, and makes recommendations for the implementation of the Convention.

At the opening meeting on Monday, 8 July, the Committee will be addressed by a representative of the Secretary-General and adopt its agenda. The Chairperson of the Committee, Nicole Ameline, will brief the Committee on activities and events occurring since the previous session that had a bearing on the work of the Committee.

In addition to considering the reports of eight States parties, the Committee will hold public informal meetings with non-governmental organizations and national human rights institutions to discuss the situation in the countries whose reports will be considered. It will also consider individual complaints as well as inquiries under the Optional Protocol to the Convention, in closed meeting. The Committee will discuss matters relating to follow-up to concluding observations and its methods of work.

## Panel Discussion on Women and HIV/AIDS

On 25 July 2013, in the morning (11:30 to 13:00), the Committee will host a high-level discussion on Women and HIV/AIDS organized by a UN Women/UNAIDS/UNDP Task Force on HIV/AIDS. This event, with the participation of the UNAIDS Executive Director, Michel Sidibé, will be publicly webcast. It aims at deepening the knowledge and understanding of how efforts to address HIV/AIDS amongst women and girls can be strengthened through working with CEDAW.

## **Convention on the Elimination of All Forms of Discrimination against Women**

The Convention on the Elimination of All Forms of Discrimination against Women was adopted by the United Nations General Assembly on 18 December 1979, and entered into force on 3 September 1981. Often described as an international bill of rights for women, the Convention both defines discrimination against women and sets up an agenda for national action to end such discrimination. Since its entry into force, the Convention has achieved near-universal acceptance, with 187 States parties.

The Convention defines discrimination against women as "... any distinction, exclusion or restriction made on the basis of sex which has the effect or purpose of impairing or nullifying the recognition, enjoyment or exercise by women, irrespective of their marital status, on a basis of equality of men and women, of human rights and fundamental freedoms in the political, economic, social, cultural, civil or any other field".

By accepting the Convention, States commit themselves to undertake a series of measures to end discrimination against women in all forms, including: incorporating the principle of equality of men and women in their legal system; abolishing all discriminatory laws and adopting appropriate ones prohibiting discrimination against women; establishing public institutions to ensure the effective protection of women against discrimination; and ensuring elimination of all acts of discrimination against women by persons, organizations or enterprises.

## **Optional Protocol to the Convention**

On 22 December 2000, the Optional Protocol to the Convention entered into force, by which States parties recognize the competence of the Committee to receive and consider communications submitted by individuals or groups of individuals claiming to be victims of a violation of their rights under the Convention.

To date, 104 of the Convention's 187 States parties have accepted the Optional Protocol. Before the Committee will consider a complaint, it first must establish its admissibility under the terms of the Optional Protocol. The Optional Protocol also enables the Committee, upon the fulfilment of certain criteria, to undertake inquiries into possible grave or systematic violations of women's rights.

## <u>Membership</u>

The Committee is made up of 23 experts of high moral standing and recognized competence in the field of women's rights. Members are nominated and elected by the States parties and serve in their personal capacity.
